REPAIR STORM STRUCTURES

Where pipe is removed and an opening remains in an existing storm sewer structure, the Contractor shall plug or otherwise repair the opening. The cost to repair the opening shall be included in the cost of Pipe, Remove. No direct payment will be made to repair an opening in a storm structure.

CAP EXISTING DRAINAGE STRUCTURES

Description

This work shall consist of capping existing drainage structures that are to be abandoned in place.

Materials

Materials shall be 0.75-inch-thick steel plate and earthen backfill.

Construction Requirements

Structures designated to be capped shall be clear of all debris prior to the commencement of the work. Capping of existing structures shall occur only after the structure is no longer used for existing drainage.

Existing structures which are to be abandoned but shall remain in place at the completion of construction shall have a 0.75-inch thick steel plate placed on the top of structure and backfilled with earth.
